- 4 Out of Rs.3249.97 lacs written off during earlier years, an amount of of Rs.78.96 lacs, other than capital receipts of Rs.91.59 lacs has been considered as income of the company during the quarter ended 31.03.2006.
- 5 The registered office of the company has been shifted from Haryana to Delhi.
- 6 There were 23 investor complaints outstanding as on 31st March, 2006, which have since been resolved.
- 7 The figures of previous periods have been re-grouped whenever necessary to conform to this period classification.
