ENVIRONMENT, HEALTH, AND SAFETY POLICY

1. Objective

2. Applicability

When working with contractors, suppliers, and other entities collaborating with NSIL or acting on its behalf, NSIL will promote principles and commitments consistent with this policy. All employees (including contractors, part-time employees, workers, and trainees) must comply to the policy when acting on behalf of NSIL.

3. Key Responsibilities

Risk Management Committee of the Board of Directors of the Company oversees the implementation of this policy.

Executive management has the overall accountability for ensuring implementation of this policy.

Department heads, including line managers, are responsible for the full implementation of this policy and provide periodic updates to the executive management about the good practices implemented and evolving challenges with reference to environment, health and safety throughout the organisation.

4. Policy Guidelines

• **Protect the Environment**

We promote sustainable development across our operations by identifying and implementing opportunities for effective use of resources, pollution prevention, emission reduction and waste reduction. In order to advance our Environmental Stewardship initiatives for reducing the environmental footprint and promoting sustainability, we would explore opportunities to work with public and private entities, including governments, non-governmental organisations, other businesses, suppliers, academic institutions, and local communities.

• **Maintain Safety as the First Priority**
